

# Frequently Asked Questions

## **What is Statement of Legal Residence (SLR)?**

The Statement of Legal Residence (SLR) is an online questioner that asks a series of questions to determine if a student pays in-state or out-of-state tuition and fees.

## **Who must complete the Statement of Legal Residence (SLR)?**

New undergraduate and graduate students attending UC Merced for the first time, as well as undergraduate and graduate students returning from an absence of one or more semesters.

## **How do I complete the Statement of Legal Residence (SLR)?**

Many new students will have completed this requirement based on how they responded to the questions in their UC application. If the Statement of Legal Residence (SLR) is listed on your checklist, you should complete the online questioner as soon as possible. This process can be completed before you submit your SIR.

If you are a continuing student and have been classified as a nonresident, review [‘How to change your nonresident status to resident’](#) section.

## **What should I do if my residence classification is not determined by the fee payment deadline?**

If your request to change residency classification is not approved by the time tuition is due, you are responsible for paying the outstanding balance on your student account including non-resident tuition and fees. Note that failure to pay the tuition by the due date will result in late payment fees and risk of being dropped from your courses.

## **How long does it take to make a determination of my resident status?**

The Statement of Legal Residence (SLR) application and documentation are processed in the order that they are received. During peak times, reviewing your Statement of Legal Residence (SLR) may take 4-6 weeks before you see an update. If required documentation is missing, or if additional documentation is required due to unclear information, it will further delay our ability to make a residency determination. You may check the status of your Statement of Legal Residence (SLR) on your student checklist or visit the [Registrar Announcements](#) for overall processing updates.

## **What are the requirements for establishing California residency for tuition purposes?**

Requirements: Dependent Students

An undergraduate student who has not reached age 24 is considered to be a dependent student. Dependent students and parents must concurrently satisfy the Residency Requirements.

1. **Physical Presence:** The student and parent must be continuously physically present in California for more than one year (366 days) immediately prior to the [residence determination date](#) of the term for which you request resident status.
2. **Intent to remain in California:** The student and any parent they are dependent on must have established their intent to make California their permanent home one year prior to the residence determination date (greater than 365 days), as well as relinquished ties to any prior place of residence outside of California.
3. **Immigration status for student:** The student must have the legal ability to establish a permanent domicile in the United States, meaning that you must be a citizen or permanent resident of the United States or hold a valid, qualifying nonimmigrant visa.

Immigration status for parent(s): Any California resident who is a U.S. citizen or permanent resident of the U.S, whose parent is undocumented or out of status but has otherwise been physically present in California with concurrent intent to remain in California for 366 days, will be eligible for resident classification.

\*If you are a dependent student who wishes to qualify as an Independent student, you must demonstrate that you have been fully self-supporting for one-year prior to the residence determination date. Supporting documentation will be required.

#### Requirements: Independent Students

A student who is deemed to be an Independent Student based on one of the requirements in the [UC Residency Policy](#) may satisfy the requirements without regard to a parent. Independent students must satisfy the Residency Requirements.

1. **Physical Presence:** The student must be continuously physically present in California for more than one year (366 days) immediately prior to the residence determination date of the term for which you request resident status.
2. **Intent to remain in California:** The student must have established their intent to make California their permanent home one year prior to the residence determination date (greater than 365 days), as well as relinquished ties to any prior place of residence outside of California.
3. **Immigration status for student:** The student must have the legal ability to establish a permanent domicile in the United States, meaning that you must be a citizen or permanent resident of the United States or hold a valid, qualifying nonimmigrant visa.

## **Residence Determination Dates at UC Merced**

- **Fall 2022:** August 24, 2022
- **Spring 2023:** January 17, 2023
- **Fall 2023:** August 23, 2023
- **Spring 2024:** January 16, 2024

## **Can I obtain residency if I am not a U.S Citizen, Permanent Resident, DACA or qualifying visa holder? If so, how?**

[Assembly Bill 540](#) allows eligible undocumented, legal permanent resident and U.S. citizen students to pay in-state tuition and fees, and not the supplemental tuition charged to nonresidents.

In order to qualify, you must meet ALL of the following requirements:

1. Attend a California high school for 3 or more years;
2. Graduate from a California high school or receive the equivalent, such as a GED; and
3. Submit an affidavit to the California university you are attending or plan to attend.

In 2017, SB68 helped expand AB540 to enable students to count Community College and Adult School towards AB540 Eligibility. You can read about SB68 [here](#).

## **Can I tell you my circumstances and have you tell me if I will qualify for residency?**

We will not make a residency determination without reviewing a completed Statement of Legal Residence (SLR) application and supportive documentation.
